To meet Alan today, you wouldn't recognise him.

Since Alan's involvement in Alive's intergenerational project iPals, he is a new man. Care staff describe him as having a new lease of life.

Being a part of the iPals project has given him confidence and a sense of purpose. Alan is now writing and running the care home's magazine! It keeps him busy, and has provided him with a hobby which he loves! It's also raised Alan's profile in the care home, he's the iPals expert. When Alan first arrived at his new care home he was very unwell and depressed. From his first initial assessment, staff thought he would not be with them for long. The care home's Manager knew intervention was crucial. As a forwardthinking care home, they had agreed to be a part of Alive's iPals project, and decided that Alan would benefit from getting involved. iPals is an intergenerational project bringing together younger and older people

through the shared use of technology. The care home was linked with children from St Stephen's Junior School. During theirvisits, each child is paired with an older person, and they use iPads to explore each other's hobbies and interest. Not only does the project provide opportunities for the residents to mix with younger people, it also provides access to learning which is important for anyone at any age.

Once you've set your fundraising goal, tell everyone!

It will help to stay motivated right up until the big day, before you set the date, make sure you've given yourself plenty of time to get everything in place, for friends, family and colleagues to put the date in their diaries. Pick a day that is easier for people to remember, such as the weekend or at work where everyone is in the office.

Spread the word, tell people why you're raising funds for Alive **Facebook** and **Twitter** are ideal for inviting and updating people.

If possible, write a blog about your progress, it just keeps your supporters involved and they may be able to help.

2. Make it easy with an online fundraising page

Raising money online couldn't be simpler. If you haven't already, set up a JustGiving fundraising page. Go to https://www.justgiving.com/aliveactivities so your friends and family can sponsor you in a matter of minutes.

It's easy to set up and manage. Your friends and family can sponsor you from anywhere at any time and you don't need to spend time collecting money. You can also use hard copy donation forms, giving friends and family two ways to support you.

If you are a UK taxpayer, JustGiving will automatically reclaim at least 25% in Gift Aid on your donation at no additional cost to you.

Make your page as interesting as possible by adding photos and videos and letting everyone know why you're raising money for Alive.

Share your page on Facebook and Twitter and email it to your friends and family. More and more donations are being made via social media so be sure to share a link to your page.

Set up your own **Text code**, make it even easier for people to support you. It will mean that anyone can send a donation by text and it will be added automatically to your JustGiving total.

First, you will need your JustGiving page up and running then you just log into your account and follow the instructions.

3. Keep it safe and legal

Collections

It is important to make sure the correct permissions are in place before carrying out collections. If you are collecting in publicly own places, town centres and on the pavements, you must get a license by the relevant licensing authority, usually it's the local authority and/or the police.

Raffles, lotteries and prize draws

Small lotteries – raffle, tombola at a single event - If you run a raffle or tombola at your fundraising event, tickets can only be sold at the event, then you will not need any kind of lottery licence. Standard cloakroom tickets can be used to represent the 'chances' sold.

However, if you are holding the event on public property (and in Scotland, on private property where the public have unrestricted access), you will need to apply to your local council for a street collection licence to be able to sell your tickets.

Private lotteries – raffle at work, or within a society (not open to the public)

There is no need for a lottery license should your group organise a raffle outside of a fundraising event but confine ticket sales to members of a club, society or group of people who live or work on the same premises. This is only permissible provided that the group has not been established for purposes connected to gambling. The organiser or 'promoter' of the private lottery should be a member of the group concerned.

There is no specific board or body in existence to regulate private lotteries. However, do remember the following:

- The price of all tickets must be the same
- Each ticket must specify the name and address of the organiser (promoter), the registered charity number e.g. 1132708 and the ticket price.
- Each ticket must declare who is entitled to buy a ticket, and that prizes will only be awarded to the rightful winner.
- Tickets cannot be sent through the post and can only be advertised at the point of sale.

As a general rule of thumb, you are more likely to need a licence if you want to sell tickets to general members of the public over an extended period of time.

Data protection

Make sure that any electronic or paper record you keep about people involved in a fundraising event complies with the Data Protection Act. As a rule of thumb, don't keep information about people any longer than you must, and don't share information or data about someone without their permission.

Insurance

When you organise a fundraising event, you are responsible for making sure it poses no risk to others. That's why we would recommend you take out public liability cover for events such as a sponsored walk or sports event.

Alive Activities cannot accept liability for any loss, damage or injury suffered by yourself or anyone else as a result of taking part in a fundraising event.

4. Don't forget to gift aid it

If you are a UK taxpayer, you can increase the value of your donations by 25% and it won't cost you a penny. All you need to do is sign a **gift aid declaration** and we will be able to clain the extra cash from HMRC.

What is GiftAid?

It's a tax efficient way of donating to charity. Gift Aid allows us to claim the basic rate of income tax (currently 20% on a donation from a tax-paying donor, from HMRC. So, for every £1 donated, we can claim an additional 25p.

How do I know if I'm a UK taxpayer?

If any of the following apply to you, you're a UK taxpayer

- a. Tax is taken from your salary before you receive your pay
- b. You complete s self-assessment tax return form
- c. You have recently paid capital gains tax, or expect to do so in the near future
- d. You have taxable savings, a pension plan or investment income. Please note: inheritance tax does not count as UK income tax

What if I am not a UK taxpayer?

If you are not a UK taxpayer, we can't claim Gift Aid on your donations. If you have signed a declaration in the past but no longer pay tax please contact us on: 0117 377 4756 so your records can be updated.

What if I am a higher rate taxpayer?

If you are a higher rate taxpayer, the charity can still only reclaim the basic rate, and you can claim a tax rebate for the difference between the basic rate of tax and your highest rate if you make a charitable donation.

Instructions to the site holder of static Alive!'s collection tins

Alive would like to thank your company/organisation for agreeing to collect donations on behalf of our charity.

Static collecting boxes are amongst the most effective and efficient forms of fundraising and provide visible evidence your company's social responsibilities to the community.

It is important that the authorities and the general public alike retain confidence in such a valuable source of charitable funds.

Here are simple guidelines to ensure the proper management and use of static collection boxes and to safeguard the public interest in their use.

- Please display your certificate of authority that has been provided to you by Alive
- Appoint a member of staff to be the authorised person to open the boxes and to keep the boxes safe
- Maintain records of where boxes are sited and how much money is collected in each box
- keep separate accounting records showing money raised through static collecting boxes
- When emptying the boxes please make sure the authorised person opens the box in the presence of another person, once the contents has been counted, 2 signatures are needed on the accounting records.
- Once emptied, a new seal must be placed on the top of the collection box. The middle part of the seal needs to be stuck on the bottom of the box. Seals are provided by Alive
- Filling in the seal label, *Box number* each box will have a number underneath, *Name* Alive Bristol BS1 6XN. *Date* when box was emptied.
- Each static box will have an Alive! label with the charity registration no. 1132708 and address. Labels must be clearly visible. Please contact Sarah on 0117 353 3966 or fundraising@aliveactivities.org

Gift Aid - Make your gift worth more at no extra cost to you, if you are a UK taxpayer. Gift Aid means that for every £1 you donate, we can claim an extra 25p from HMRC. Please make sure you fill in your full name, full address and postcode, and tick the Gift Aid box below.
