About Alive:

Alive is one of the leading practitioners in the UK of meaningful activity for older people. Not only do we provide meaningful engagement in care homes, we provide community activity and support through our Meeting Centres and community gardening. We run a range of innovative community and care home projects, bringing art, sport, IT, gardening and intergenerational connections to older people. We work online with our subscription service Alive On Demand, and we deliver face-to-face in groups and in care homes. We believe in true co-production; our activity is shaped by older people and we engage using a variety of tools and techniques, tried and tested over the last 13 years.

Organisational Structure:

Alive is a registered Charity. Our Board of Trustees has 7 members and we meet 4 times a year. Subsequent groups meet outside of this to help the development of the Charity.

The day-to-day management team involves 25 staff; the Senior Management includes a full-time CEO, Business Development Manager and Training and Services Manager and part-time Services Development Manager and Finance Manager. Many of the remaining staff are project funded and most are of a part-time appointment.

Role Description:

We are looking to recruit new members for the Board of Trustees. You would need to be passionate about our mission and vision and want to work in line with our values and ethos. We would like to improve the diversity of our Board in every respect.

The Board of Trustees is jointly responsible for the overall governance and strategic direction of the charity, its financial health, its activities and developing the organisation's aims. All trustees should also be aware of, and understand, their individual and collective responsibilities.

Duties:

- To ensure that the charity pursues its objectives;
- To ensure the charity complies with its 'governing documents';
- To ensure that the charity applies its resources exclusively in pursuance of its objectives;
- To act within the spirit of, and in accordance with, Alive's values and policies;
- To contribute actively to the Board of Trustees' role in giving firm strategic direction, setting overall policy, defining goals and setting targets and evaluating performance agreed targets;
- To safeguard the good name and values of the organisation;
- To act in the best interests of beneficiaries and avoiding conflicts of interest;
- To ensure financial stability of the organisation, including the proper investment of the charity's funds;

The above list of duties is indicative only and not exhaustive. Trustees will be expected to perform all such additional duties as are reasonably commensurate with the role.

Commitment:

- Commitment to the organisation and a willingness to devote the necessary time and effort is vital;
- Attend Board meetings four times a year, usually held early evening on a weekday and lasting about two hours;
- Prepare for Board meetings by reading meeting documents circulated in advance;
- Participate in other occasional sub-committee and strategy meetings as required;
- Attend Alive events as required;
- Willingness to be available to the management team for advice and enquiries on an ad hoc basis.

Qualities Skills and Experience:

- The ability to work well as part of a diverse team;
- To build good working relationships with the board, stakeholders, staff and service users;
- To be reliable and hard-working;
- Experience of working at strategic level preferably in the charity or voluntary sector;
- To be committed to the cause and have a wider balanced perspective
